

# INDEPENDENT STUDENT STATUS DOCUMENTATION

## INDOC 2009-2010

When you completed the 2009-2010 FAFSA application, you answered "YES" to one of the questions listed below. Please check the appropriate box that applies to you and submit the required documentation.

### FAFSA QUESTIONS

- #50. At the beginning of the 2009-2010 school year, will you be working on a master's or doctorate program (such as an MA, MBA, MD, JD, PhD, EdD, graduate certificate, etc.)?  
**Required Documentation—This should always be answered "NO". We don't have Graduate Programs at FCCJ.**
- #51. Are you currently service on active duty in the U.S. armed Forces for purposes other than training?  
**Required Documentation—Copy of Active Duty Military ID Card, or other documents showing active duty.**
- #53. Do you have children who will receive more than half of their support from you between July 1, 2009 and June 30, 2010?  
**Required Documentation—Birth certificates of children being claimed.**
- #54. Do you have dependents (other than your children or spouse ) who live with you and who will receive more than half of their support from you, now and through June 30, 2010?  
**Required Documentation—Copy of taxes filed showing dependents claimed as exemptions, or other documentation that shows you are contributing more than half of their support.**
- #55. At any time since you turned age 13, were both your parents deceased, were you in foster care or were you a dependent or ward of the court?  
**Required Documentation—Death certificates of both deceased parents, or court document showing you were a ward of the court and when.**
- #56. Are you or were you an emancipated minor as determined by a court in your state of legal residence?  
**Required Documentation—Court document from your state of legal residence where you were emancipated.**
- #57. Are you or were you in legal guardianship as determined by a court in your state of legal residence?  
**Required Documentation—Court document from your state of legal residence where you were placed under legal guardianship of another person.**
- #58. At any time on or after July 1, 2008, did your high school or school district homeless liaison determine that you were an unaccompanied youth who was homeless?  
**Required Documentation—Document on Letterhead stationary from either your high school or school district homeless liaison verifying this status.**
- #59. At any time on or after July 1, 2008 did the director of an emergency shelter or transitional housing program funded by the U.S. Department of Housing and Urban Development (HUD) determine that you were an unaccompanied youth who was homeless?  
**Required Documentation—Document on Letterhead stationary from the director of the emergency shelter or HUD verifying this status.**
- #60. At any time on or after July 1, 2008, did the director of a runaway or homeless youth basic center or transitional living program determine that you were an unaccompanied youth who was homeless or were self-supporting and at risk of being homeless?  
**Required Documentation—Document on Letterhead stationary from the director of the runaway or homeless youth basic center or transitional living program verifying this status.**
